



NWW non-medical care management offices are located throughout the continental United States and Hawaii, and staff is able to assist from any location. Offices are located:







Navy Wounded Warrior

The Navy Wounded Warrior (NWW) Program is the Navy's sole organization for coordinating the non-medical care of seriously wounded, ill and injured Sailors and Coast Guardsmen. NWW provides resources and support to their families and caregivers. Through proactive leadership, the program provides individually-tailored assistance designed to optimize the success of the wounded warriors' recovery, rehabilitation and reintegration activities.



NWW provides non-medical assistance to Sailors and Coast Guardsmen to support their medical recovery as they work to return to duty. If this is not possible due to their medical condition, the program works collaboratively with federal agencies and state and local organizations to ease wounded warriors back into their communities.

How Does NWW Operate?

Regional NWW non-medical care management teams work with wounded warriors and their families to identify their needs and goals and develop plans to achieve them. The teams are led by regional program directors, and recovery care coordinators (RCC) oversee the developments and execution of wounded warriors' Comprehensive Recovery Plans (CRP). Non-medical case managers (NMCM) anticipate enrollees' daily non-medical needs and liaison with stakeholders to resolve any issues that surface during the recovery processes.



What is a CRP?

A CRP is an individualized plan developed by the non-medical care management team, the service member and his or her family or caregiver, which identifies and prioritizes the enrollee's goals. The CRP is a tool that helps service members remain on course throughout recovery, rehabilitation and reintegration.

How do Sailors and Coast Guardsmen Enroll in NWW?

Sailors and Coast Guardsmen may self-refer to the program or be referred by family members, command leadership, medical providers, chaplains, PEBLOS, and numerous additional sources.



Who is Eligible for Enrollment?

NWW enrollment is available to seriously wounded, ill and injured Sailors and Coast Guardsmen, including:

- OIF/OEF/OND casualties
- Shipboard and training accidents
- Liberty accidents
- Serious medical and psychological conditions (e.g., cancer, severe PTSD)

What is Non-Medical Care Management?

Regional NWW non-medical care management teams tailor support to each enrolled service member's needs. The goal is to support enrollees through recovery, rehabilitation and reintegration to active duty or into the community.

Support includes assistance with:

- Comprehensive Recovery Plan
- Pay and personnel issues
- Invitational Travel Orders to bedside for family
- Lodging and housing adaptation
- Child and youth care
- Caregiver support
- Adaptive sports and reconditioning
- Educational benefits and training and employment opportunities
- TBI/PTSD support services
- Transition assistance
- and much more
